

## **Dancing with the Stars and Stripes 2020 Raffle -- OFFICIAL RULES**

**1. Eligibility:** The “**Main Raffle**” is open only to those who purchase a ticket or receive a ticket with their VIP package or as a prize and who are **18 years old** as of the date of entry. People in the following positions and their immediate families (parent, spouse, child) residing in the home are ineligible as raffle winners: employees and board members of VRC and Dancing with the Stars and Stripes event leadership as follows: Event Manager, Event Coordinator, Director, Lead Raffle Coordinator, Master of Ceremonies. Corporations and organizational entities are also ineligible.

**2. Agreement to Rules:** By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of **VRC**, as final and binding as it relates to the content. The Raffle is subject to all applicable federal, state and local laws. Void where prohibited.

**3. Raffle Period:** Entries for the Main Raffle will be accepted in person starting on or about **November 5, 2019** and ending **April 25, 2020** at the end of intermission or the time announced during the live show, whichever is later.

### **4. How to Enter:**

The **Main Raffle** may be entered by meeting the eligibility requirements stated above, completing a raffle ticket stub, and returning it to an authorized representative by April 1<sup>st</sup>, 2020. Completed tickets purchased at the event must be placed in the box in the lobby by the end of intermission. You may enter more than once, identity information must be listed on each ticket stub. Tickets are non-refundable.

**5. Prizes:** VRC will give away a minimum of the following prizes in the **Main Raffle: A hot air balloon flight and 2 nights’ lodging in Sonoma County; 2 tickets to the Napa Valley Wine Train, \$500 gift card to Friedman’s Home Improvement store.**

The specifics of each prize shall be solely determined by the Donor. No cash or other prize substitution permitted except at Donor's discretion. Any and all prize related expenses, including without limitation, transportation, and any and all federal, state, and/or local taxes, shall be the sole responsibility of the winner. No substitution of prize or request for the cash equivalent by winners is permitted. Travel and/or experiences must be completed by the date indicated on the prize certificate presented to winner when applicable. Acceptance of prize constitutes permission for **VRC** to use winner's name, likeness, and entry for purposes of advertising without further compensation, unless prohibited by law.

**6. Odds:** The odds of winning depend on the number of eligible entries received.

**7. Winner selection and notification:** Winners of The Raffle will be selected in a random drawing at the Dancing with the Stars and Stripes event on April 25<sup>th</sup>, 2020. The Main Raffle may be postponed if all sold tickets are not confirmed received by the time of the drawing. Winners drawn in the Main Raffle will have their choice of prizes in the order drawn and need not be present to win. 1<sup>st</sup> drawn gets 1<sup>st</sup> choice, 2<sup>nd</sup> drawn gets 2<sup>nd</sup> choice, etc. Winners of the Main Raffle will be notified by phone and/or via email as listed on their Raffle ticket with within five (5) days following the winner selection. **VRC** shall have no liability for a winner's failure to receive notices due to winners' spam, junk e-mail or other security settings or for winners' provision of incorrect or otherwise nonfunctioning contact information. If the selected Main Raffle winners cannot be contacted, are ineligible, decline, or fail to claim the prize within 21 days from the time award notification was sent, prize may be forfeited, and an alternate winner selected. Acceptable photo identification must be presented to claim the prize, and all forms of payment for the ticket purchase confirmed settled. The receipt by winners of the prizes offered in The Raffle is conditioned upon compliance with all federal and state laws and regulations. Any violation of these official rules by any winner (at VRC’s sole discretion) will result in such winner's disqualification as winner of The Raffle and all privileges as winner will be immediately terminated.

**8. Rights Granted by You:** By entering The Raffle you understand that **VRC**, anyone acting on behalf of **VRC**, or its respective licensees, successors and assigns will have the right, where permitted by law, without

any further notice, review or consent to print, publish, broadcast, distribute, and use, in any media now known or hereafter in perpetuity, your entry, including, without limitation, the entry and winner's name, picture, voice, likeness, image or statements about The Raffle, and biographical information as news, publicity or information and advertising, public relations and promotional purposes without any further compensation.

**9. Terms:** **VRC** reserves the right, in its sole discretion to cancel, terminate, modify or suspend The Raffle should (in its sole discretion) fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of The Raffle. In such case, **VRC** may select the recipients from all eligible entries received prior to and/or after (if appropriate) the action taken by **VRC**. **VRC** reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of The Raffle or violates these Terms & Conditions.

**VRC** has the right, in its sole discretion, to maintain integrity of The Raffle, and to take steps necessary to do so. Any attempt to deliberately undermine the legitimate operation of The Raffle may be in violation of criminal and civil laws and should such an attempt be made, **VRC** reserves the right to seek damages from any such person to the fullest extent permitted by law.

**10. Limitation of Liability:** By entering you agree to release and hold harmless **VRC** and its subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, donors, employees, officers and directors from any liability, illness, injury, death, loss, litigation, claim or damage that may occur, directly or indirectly, whether caused by negligence or not, from (i) such entrant's participation in The Raffle and/or his/her acceptance, possession, use, or misuse of any prize or any portion thereof, (ii) technical failures of any kind, including but not limited to the malfunctioning of any computer, cable, network, hardware or software; (iii) the unavailability or inaccessibility of any transmissions or telephone or Internet service; (iv) unauthorized human intervention in any part of the entry process or the Promotion; (v) electronic or human error which may occur in the administration of the Promotion or the processing of entries.

**11. Disputes:** The Raffle is governed by the laws of **the United States** and **California**, without respect to conflict of law doctrines. As a condition of participating in The Raffle, participant agrees that any and all disputes which cannot be resolved between the parties, and causes of action arising out of or connected with The Raffle, shall be resolved individually, without resort to any form of class action, exclusively before a court located in **California** having jurisdiction. Further, in any such dispute, under no circumstances will participant be permitted to obtain awards for, and hereby waives all rights to claim punitive, incidental, or consequential damages, including reasonable attorneys' fees, other than participant's actual out-of-pocket expenses (i.e. costs associated with entering The Raffle), and participant further waives all rights to have damages multiplied or increased.
